Based on the result of Computer Based Test(CBT) conducted by Railway Recruitment Boards(RRBs) and Physical Efficiency Test conducted from 17.01.2023 to 21.01.2023 at SERSA Stadium, Kharagpur for Non PWBD candidates by South Eastern Railway for the Level-1 Posts of 7th Central Pay Commission (CPC) against Centralized Employment Notice No.RRC-01/2019, the shortlisted candidates have been called for verification of Original documents and genuineness of candidature on the basis of merit from 13.02.2023 to 27.02.2023 and absentees were called on 01.03.2023. On completion of verification of original documents and genuineness of candidature and Medical examination, in compliance of all other procedure laid down by Railway Board, Railway Recruitment Cell, South Eastern Railway hereby declares the Provisional Panel Part-3 consisting of 61(Sixty One) [Non PwBD-56 & PwBD-05] candidates.
2. Allotment of Posts, Division/Units shall be decided in due course and shall be subject to availability of vacancies, requisite Medical fitness, Option etc. Offer of appointment shall be dispatched by respective Divisions/Units.
3. Merit & Rank shall be declared at a later stage.
4. The results of some candidates those who are in merit list have not been declared due to non-receipt of Medical FIT certificates and also the cases which were not cleared at Document Verification stage. However, while publishing the panel their merit position was kept in view and once their cases are cleared they will be restored to their actual merit position.
5. While due care has been taken in preparing the result, RRC-South Eastern railway reserves the right to make amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices is noticed or brought to the notice of RRC at any stage, RRC-SER reserves the right to rectify any inadvertent error or typographical/Printing mistakes and declare any candidate unsuccessful or delete the name of candidate from the notified panel.

7. This is only a Provisional Panel and NOT THE FINAL PANEL which does not confer upon the candidates any right for appointment in Railway Service.
