

In compliance to Hon'ble High Court, Kolkata's Order dated 11.05.2023 & 26.07.2023 in RVW 141/2023, CAN 1/2023 in WPCT 88 of 2023 Buddhadev Senapati & Ors. Vs. UoI & Ors, 158 candidates who are found eligible in Document Verification by the Screening Committee have been subjected to PET(Physical Efficiency Test) on 15.09.2023, out of which 2 PwBD candidates have been exempted from PET as per Railway Board's letter No.E(NG)II/2006/RC-2/11 dated 20.07.2007. Further, the following candidates have been found ineligible in Document Verification by Screening Committee for the reasons mentioned against their names.
