NOTICE

The **Non-PwBD** candidates with Roll Numbers as mentioned in **Annexure-1** who are found fit in medical category **B2 to C1** medical standard could not be empanelled due to non-availability of posts for **B2 & C1** category at present.

The candidates are hereby intimated that they can prefer an appeal against their Medical category, if they so desire, before Chairman/RRC/SER within one month from the date of issuance of this notice.

The candidate preferring an appeal against the decision of Railway doctor, should submit the same with due justification. Such an appeal shall be entertained, only if, the candidate produces a certificate as per the format mentioned in **Proforma 'A'** from a Government/Private Doctor of the speciality/Specialities in which the candidate has been found not fit. Such a certificate should contain a note that the Government/Private specialist is fully aware of the physical and visual standard set by the Railways for the particular medical category, and that his aware of the fact that the candidate has already been declared not fit according to this standards during Medical Examination. The certificates should bear the photograph and mark of identification of the candidates duly attested by such a Government/Private issuing Authority. Such an issuing Authority shall also clearly mentioned its MCI/State registration Number. The candidate will be required to pay **Rs. 1000/-** through DD payable in favour of **FA&CAO, South Eastern Railway**.

In case, the decision of the Railway Medical Doctor / Committee / Board on re-medical examination changes in favour of the candidate, the amount of Rs 1,000/- shall be returned to the candidate.

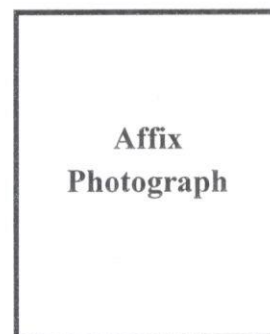
