NOTICE FOR DOCUMENT VERIFICATION

GDCE Notification No. SER/P-HQ/RRC/GDCE/2022

1. Based on the result of Computer Based Test (CBT) conducted on 15.03.2022 and Typing Test conducted on 28.04.2022 for the Level – 2 Junior Clerk -cum-Typist of 7th Central Pay Commission (CPC) against GDCE Notification No SER/P-HQ/RRC/GDCE/2022 dated 17.01.2022, the following candidates who qualified in the Typing test have been called for Verification of Original documents and genuineness of candidature on the basis of their in Computer Based Test (CBT).

2. Amongst 2324 candidates shortlisted for Typing Test, 1956 candidates appeared in Typing Test (4 PwBD candidates exempted to appear in the Typing Test). A total number 563 candidates qualified in Typing Test. The details of candidates called for Document Verification against the vacancies notified community wise in order of merit are as under:-

3. As Typing Test is only of qualifying nature, list of employees who have qualified for Document Verification is prepared on the marks obtained in the CBT.

4. The candidates called for Document Verification (DV) in the ratio of 1:1 of notified vacancy for the post of Junior Clerk cum Typist is annexed herewith along with the date of DV, schedule/time and instructions.

5. There is a tie of marks at 55th to 58th position of shortlisted OBC candidates. However, as per Railway rules, among the persons with equal merit, the older persons (based on officially recorded date of birth) will be considered than the younger persons, for drawing select list in the ratio of 1:1 of the notified vacancy. As such four older persons based on their date of birth with equal merit called for DV.

6. Only in case of a shortfall, candidates who are lower in merit will be called as per community. Candidates called for DV will have to be declared fit in C-2 medical category before being final empanelled.

7. The candidates will have to submit the relevant original documents before the

committee nominated for document verification. If a candidate fails to do so then it will immediately lead to cancellation of candidature.

8. Candidate is required to report on the DV Venue, on the allotted Reporting Date & Time as per the call letter, without fail. Supplementary DV will not be conducted unless due to administrative decision/exigency.

9. No companions or representatives are permitted at the DV venue, both for male and female candidates. The candidate should follow instructions issued by railway officials at the DV venue, regarding maintenance of discipline for smooth conduction of DV. Impersonation/malpractice/ indiscipline in the DV will disqualify the candidature and he/she will be debarred from all future railway recruitments. Candidate is also liable to be prosecuted under D&AR.

10. Candidate is instructed to download & take clear print out (front and back pages) of the e-call letter from the website. DV call letter will not be sent to candidates by post.

11. Clearly readable print of e-call letter (front and back pages) should be produced by the candidate, at the DV venue. Candidate will not be allowed for DV without producing the DV call letter. The photo of the candidate shall be clearly visible in printout so that no confusion regarding his/her identity takes place.

12. At least one original and valid photo identification card such as Employee ID, PAN Card, Aadhaar and relieving letter issued by the UNIT where photo of the candidate is attested by relieving officer must be presented, failing which candidate will not be permitted in the DV.

13. Original documents and photocopies (self attested) in support of educational qualification along with mark sheets, Caste certificate (if any) and Disability/PWD certificate (if any), should be submitted to DV officials for verification.

14. Candidate must also bring two color photographs (size 35 mm x 35 mm), same as which was uploaded in the online application form with clear front view of the candidate without cap and sunglasses.


15. The candidate is provisionally shortlisted for Verification of Documents / Certificates & genuineness of candidature. The call letter does not provide any claim for the notified post and candidature is purely provisional.

16. Candidates are also advised to keep the following necessary documents in readiness for appearing in the scheduled DV:-

(i) Candidates' portion of call letter of CBT and Typing Test in original.

(ii) All the original copies of mark sheets, certificates of educational qualification as mentioned in his/her online application.

(iii) The caste certificate, in original, if applied for relaxation as reserved community which should have been issued prior to the date of issuance of notification. The same should be as per annexure attached with the notification.

(iv) For OBC/Non Creamy layer candidates, the certificate of community should not be older than one year from the date of issuance of notification. The same should be as per annexure attached with the notification and should be produced in original.

(v) PWD candidate should bring the original PWD certificate which should be as per annexure attached with the notification and should be produced in original.

17 Failure to report for DV and to follow the attached instructions can lead to cancellation of candidature, without any further notice. Candidates are advised to keep alive their registered e-mail and phone number and check the official website of RRC-SER notice board regularly for updates as no information will be sent by post. The link for e-call letter download for DV will be uploaded soon.

18. While due care has been taken in preparing in the result, in case of any inadvertent error/s is noticed at any stage RRC-South Eastern Railway reserves the right to rectify it at later stage of selection procedure.

19. This is only provisional result and NOT the FINAL panel and qualifying for Document Verification does not entitle any employee to be appointed on the respective post.

20. RRC-South Eastern Railway reserves the right to declare any employee unsuccessful or delete his/ her name from the notified result /panel at any stage of the selection procedure, if any discrepancy or malpractices is noticed or brought to the notice of RRC at any stage. The decision of RRC in the matter shall be final.

RRC will not entertain any individual queries in this regard.
